

The Coast League Terms and Conditions/Waiver & Release of Liability

By signing below, Participant agrees to the following terms and conditions of participating in The Coast League ("The League") hosted by The Coast League.

1. **Medical Condition & Authorization.** I certify that the named Participant is physically able to participate in The League and that I know of no restrictions, physical impairments, or any other facts, which in any manner limit his/her participation in such a program. I also understand that The Coast League will administer no physical examinations and that The Coast League will rely solely upon the information shown on this form.

2. **Financial Responsibility & Insurance.** I will be financially responsible for any medical attention needed during The League or resulting from an injury received while participating in The League. I represent that I have provided and maintain adequate health and medical insurance coverage for Participant covering any and all activities related to The League. My medical insurance shall be the insurance coverage for any medical treatment. If I do not have medical insurance, I represent that I understand that I am personally responsible for any medical treatment for injuries received while participating in The League. I also understand and agree that The Coast League shall not assume, or be responsible or liable for expense, medical treatment, or compensation for any injury to the named Participant may suffer during league participation or related activities.

3. **Compliance with League Rules.** Participant understands and agrees to comply with all of The Coast League rules, policies and stated and customary terms, conditions or requirements for participation (League Rules) including any rules or conditions of any hotel or transportation service provider in which participant uses during The League. I agree that if my failure or unwillingness to comply with League Rules will result in your removal from League events. Also, I hereby release and forever discharge The Coast League and its assigns, affiliates, members and attorneys from any and all claims, actions, damages, or liabilities (including attorney's fees and costs), arising from or related to any acts, actions, failures to act by Participant or Participant's disregard or failure to follow League Rules.

4. **Assumption of Risk of League Activities.** I understand the risk of injury from the activities involved in The League is significant, including the potential for permanent disability and death. The term "League Activities" includes but is not limited to; travel to and from League games, activities before and after instruction at any The Coast League or third-party facilities at which a League activity or function is conducted. While the particular League rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of The Coast League, and its Coaches, Staff, League Management, and Directors, and if applicable the owners and lessors of the premises used to conduct the League and I assume full responsibility for participation in The League by Participant.

5. **Release & Hold Harmless.** I hereby release and hold harmless The Coast League, and its Coaches, Staff, League Management, Directors, Sponsors, Representatives, volunteers and if applicable the owners and lessors of the premises used to conduct the League (Releases) with respect to any and all injury, disability, death or loss or damage to person or property incident to participant's involvement or participation in any and all League activities whether arising from the negligence of releases or otherwise, to the fullest extent permitted by law.

6. **Indemnity.** I hereby indemnify and hold all of the above Releases from any and all liabilities incident to my involvement or participation in any and all League activities whether arising from the negligence of releases or otherwise, to the fullest extent permitted by law.

7. **Publicity.** I understand and agree that The Coast League retains the right to use, for publicity, advertising, photographs of participants in The League. Without expectation of compensation or other remuneration, now or in the future, I hereby give my consent to The Coast League its affiliates and agents, to use my image/video and likeness and/or any interview statements from me in its publications, advertising or other media activities (including the Internet). This consent includes, but is not limited to:

a. Authorizing The Coast League and its affiliates and agents to take photographs or produce videotapes, audiotapes, electronic files, or other types of media productions that capture my name, voice and/or image, to be released to members of the media, or to be used by Full Court Advantage for the purpose of:

1. News media (online, print and/or broadcast);
2. Websites and social media;
3. Publications and/or promotional materials;
4. Medical and/or educational training;
5. Closed circuit television programs;
6. Any other lawful purpose; and
7. Advertisements

b. The information to be disclosed includes:

- (a) Photographic images of me;
- (b) Video or audio of me and/or my voice;
- (c) Permission to interview, film, photograph, tape, or otherwise make a video reproduction of me and/or record my voice;
- (d) Permission to use my name; and
